

## RESIDENTIAL REHABILITATION INVESTOR PROGRAM

Loan Amounts: \$50,000 to \$250,000

Term: 6 months, with up to one 90 day extension

Rate: 14%, interest only

Points: 5 points

Maximum Loan: Up to 70% of acquisition cost plus 100% of rehab costs (if funds

escrowed and disbursed by Cal Cap). Not to exceed 80% of

total cost and 65% of after rehab appraised value.

Individuals, LLCs, corporations, partnerships; all business Borrower Types:

purpose only

Personal Guarantees: Required

Minimum Liquidity: 3 months of interest payments impounded

FICO Score: 620+

Timeline to Fund: 10 days from complete application

Rehab Disbursements: 3 disbursements on percentage of completion reimbursement –

inspection, title endorsement and direct payment to borrower
